In case deserving candidate or non-availability of suitable candidates within prescribed age limit for the post of Lady Doctor, the case of upper age relaxation upto 05 years may be considered by the competent authority as per the provision of CFSR, 1937 as amended from time to time.

Selected candidates will be governed by the Cantonment Fund Servant Rules, 1937 and government instructions/orders from time to time. All vacancies are provisional and subject to increase/decrease.
